## 2010 - 2011 Tuition Contract

### Section I - Enrollment Policy

Current Good Shepherd School students in grades K-5 will be given priority for enrollment into the next school year's classes. Applications for new students in grades K-6 will be accepted according to the following prioritized categories in most cases:

1. Siblings of current Good Shepherd School students or children of staff
2. Children of Good Shepherd parish members in good standing
3. Children of Catholic families who are established members of parish communities
4. Children of non-Catholic families

With respect to applications for all grades, **Good Shepherd School reserves the right to refuse any application.**

**Section II - Tuition Policy:** This tuition contract represents a family's commitment to pay the full 2010-2011 tuition amount. No portion of the tuition paid or due will be refunded or canceled in the event of absence, withdrawal, or dismissal from the school. **If the student attends any portion of the year, the full tuition for the year will be charged.**

**IMPORTANT: Enrollment will not be guaranteed if initial payment is not paid by July 15, 2010.**

	Family Plan	Third child of a family (youngest) pays 1/2 of tuition cost. Fourth child of a family (youngest) pays no tuition.

\*\*\*"Parishioner" includes only registered members of Good Shepherd parish **at the time of school registration.** Parishioners of other community parishes will be assessed the non-parishioner tuition rate. Financial aid or other tuition assistance may be available through your parish. All subsidy arrangements are an agreement between your family and your parish. You are responsible for any required application and compliance issues.

### Section IV – Fees

- A registration fee of \$100.00 is required at the time of registration for all new students and is **non-refundable**.
- A **non-refundable** individual student fee of \$100 is charged for students in grades 1-6 to cover field trips, assemblies, yearbook, and technology fees. The student fee is due by July 15, 2010. This fee does not include special fees such as the 6<sup>th</sup> grade Long Lake Conservation Camp and graduation trips.
- For kindergarten students, a **non-refundable** fee of \$175 is charged to cover all the above listed fees, as well as classroom supplies, cooking supplies, and daily snacks. This fee is due by July 15, 2010 as well.
- Student fees for all grade levels must be paid by July 15<sup>th</sup>, 2010.
- Accounts more than 30 days past due from the 15<sup>th</sup> of the month will be charged 1% per month or \$20, whichever is greater.
- Payments returned for insufficient funds will be charged a \$35.00 NSF fee.

**Section V - Payment Options:** Families must pay with one of the options listed below. Payments are due on the 15th of the month, beginning July 15th.

Option 1: **Payment in full** by cash, check, or credit card must be made by **July 15, 2010**.  
 Parishioner: \$3125.00 Non-Parishioner: \$4425.00

Option 2: **Payment by credit card or ACH (automatic withdraw from bank account)**

10-Monthly, due on the 15th of each month from July through April

Parishioner: \$312.50 Non-Parishioner: \$442.50

Quarterly, four payments due July 15, October 15, December 15, & February 15

Parishioner: \$781.25 Non-Parishioner: \$1106.25

Semi-annually, two payments due July 15 and December 15

Parishioner: \$1562.50 Non-Parishioner: \$2212.50

**Section VI - Delinquent Tuition Policies:** The School Board has directed the following delinquent policies. Exceptions can be approved only by the administration. If you cannot pay tuition on time, you must communicate with the school administrator in writing to prevent enforcement of delinquent tuition policies. If tuition is delinquent, enforcement may include any of the following:

- Students may not receive end of year report cards.
- Students may not participate in graduation activities.
- Students may not begin a new school year.
